Below are abridged versions of the regulations governing student conduct cited in Spartan Life. Although these interpretations should not substitute a thorough overview of the regulations themselves, they may be serve as a helpful tool at-a-glance.

Suggested Policies to Cite Based on Specified Incident Types

Alcohol in a Private Room

- GSR-2.13 – if underage present
- GSR-2.14 – if more than one person
- UHR-1.8 – if more than one person
- UHR-4.3 – if 5x occupancy

Alcohol in a Public Area

- GSR-2.13 – if underage present
- UHR-1.8 – if more than one person
- UHR-4.2 – if containers are open

Suspicion of Marijuana in a Room

- GSR-2.11 – cite in all cases
- GSR-2.12 – cite in all cases with distribution
- UHR-1.6 – if ANY smoke/smell fills the air
- UHR-1.8 – if more than one person

Smoking and Tobacco Use

- Ordinance 29.01 – cite in all cases
- GSR-4.02 – if smoke detector covered/ tampered
- UHR-1.6 – if ANY smoke/smell fills the air
- UHR-1.8 – if more than one person
- UHR-2.1 – if smoke detector covered/ tampered
- UHR-2.7 – if smoke detector is covered/ tampered

Physical Assault/Fight

- GSR-2.01 – cite in all cases
- GSR-2.04 – if coercion/intimidation were used
- GSR-4.07 – if assailant enters/remains in room w/out permission
- UHR-2.1 – if assault occurs in residence hall
